Operational Support Commences for "Sapporo Fuji Clinic" Bringing the Number of General Medical Checkup Facilities Operating with the Support of the Resorttrust Group to 14

Shinkokai Medical Corporation ("Shinkokai"), which receives operational support from Shinko Medical Support K.K. (Headquarters: Minato-ku, Tokyo, President: Yasumoto Furukawa, "Shinko Medical Support"), a consolidated subsidiary of Resorttrust, Inc. ("the Company"), succeeded the medical checkup infrastructure of Sapporo Fuji Clinic (Sapporo City, Hokkaido, Director: Masahiro Tochihara) on August 1, 2024 and commenced operations of the clinic as a new Shinkokai Group facility without changing its name.

The Company also announces that Shinko Medical Support acquired all shares of Total Healthcare Management K.K., a medical services corporation engaged in providing operational support to Sapporo Fuji Clinic, and commenced the operational support of Sapporo Fuji Clinic. The impact of these developments on the Group's financial results for the current fiscal year is minimal.

Sapporo Fuji Clinic, which is only a five-minute walk from and directly connected by an underground passage to JR Sapporo Station, is a clinic dedicated to general medical checkups and since it opened in 1985, has long contributed to the health of those who work and live in the Sapporo area by providing corporate medical checkups and medical checkups for residents including comprehensive health exams.

Shinko Medical Support, by providing operational support to the clinic, a prospective member of the Shinkokai Group, will aim to bolster operational efficiency through DX, improve customer service, promote capital investments, and achieve growth of 30% or more (annual checkup patients of 40,000 and net sales of ¥1.0 billion) in the next five years.

The Medical Operations of the Resorttrust Group uphold the vision of "Contributing to healthy longevity and personal well-being in the age of 100 years of life." Aspiring to contribute to the well-being of more people as well as consolidating our presence in the medical and healthcare industry while expanding our personal contacts and networks and securing and fostering human capital including doctors and healthcare professionals, the Medical Service Corporation Business (the general medical checkup business and the business of remote reading for diagnostic imaging) has been expanding its scale and reach, in addition to the HIMEDIC Business, which operates the membership-based comprehensive medical club, Grand HIMEDIC Club.

This will be the first time the Resorttrust Group rolls out its new business to Hokkaido, bringing the number of facilities providing general medical checkups under the operational support of the Medical Operation to 14 including the 12 facilities of the Shinkokai Group and the two facilities of the Midtown Clinic Medical Corporation Group and we expect the number of patients undergoing medical checkups at these facilities to reach approximately 600,000 per year.

Going forward, we will aim to expand our business into regions outside of the Hokkaido, Tohoku, Kanto, and Chubu regions, where we already operate facilities, and given that nearly half of all new memberships of Grand HIMEDIC Club, which has some 30,000 members, are corporate clients, we will shore up our corporate services by coordinating with the HIMEDIC Business and provide high value-added services to support health and productivity management that will satisfy the executives as well as the general employee.
